



Vendor Registration Application

- This application is for the privilege of posting in the vendor section of TDIClub.com along with a listing in the registered vendor's page. You will also receive a title on your membership indicating you are a registered vendor with or without a business number (Federal Tax Number or EIN for our US members; VAT for European members).
- To sell in the vendor section, one must be a registered member in good standing for a minimum of two months before applying to be a registered vendor.
- Only your Company name and product descriptions will be displayed on the website. TDIClub will provide vendor information when required but will not be responsible, in any way, for any litigation between a vendor and customer.
- It is your responsibility to update this information should it change. Failure to do so can result in a loss of privileges on TDIClub.com
- A registered vendor will receive no special privileges and must still abide by the TDIClub forums rules described on the website here: (<http://www.tdiclub.com/Disclaimer/ForumRules.html>).
- Registered vendors are not allowed to post in each others threads in a negative or competitive manner. If they have issues with each other they can use PM or email.
- Registered vendors are allowed to engage in technical discussion of products in the correct discussion forums, not in the classified.
- These rules are subject to change. You will be notified via your email information above if a change occurs for this form to be re-submitted.
- Registration is not advertising. With registration you are permitted to start a reasonable amount of topics in the vendor section. A reasonable amount will be determined by TDIClub management.
- Information submitted on the application form **will be verified**.
- Employees who frequent TDIClub must identify themselves in their profile as such and also be listed on the form.
- The TDIClub forums are **NOT** webpages for a vendor. Rather a mechanism to help members find products they may be interested in. This means no PayPal buttons in your posts, catalogues, daily 'bumps', etc.
- The current vendor registration is valid until June 30, 2005. Should this be canceled earlier, notification will be sent to submitted email addresses.
- A vendor is anyone who sells more than a few items kicking around his/her garage.
- Vendors group buys are limited no repeated products in a three(3) month period.
