- A Registered Vendor will receive no special privileges and must still abide by the TDIClub forums rules described on the website here: (http://www.tdiclub.com/Disclaimer/ForumRules.html).
- Registered Vendors are not allowed to post in each others threads in a negative or competitive manner. If they have issues with each other, they are to contact each other directly and personally – out of the forums.
- Registered Vendors are allowed to engage in technical discussion of products in the correct discussion forums, not in the classifieds.
